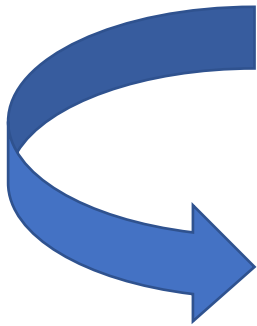


## Accreditation process for Media

**Non-right Holders** apply for accreditation **individually** using **Public Forms**



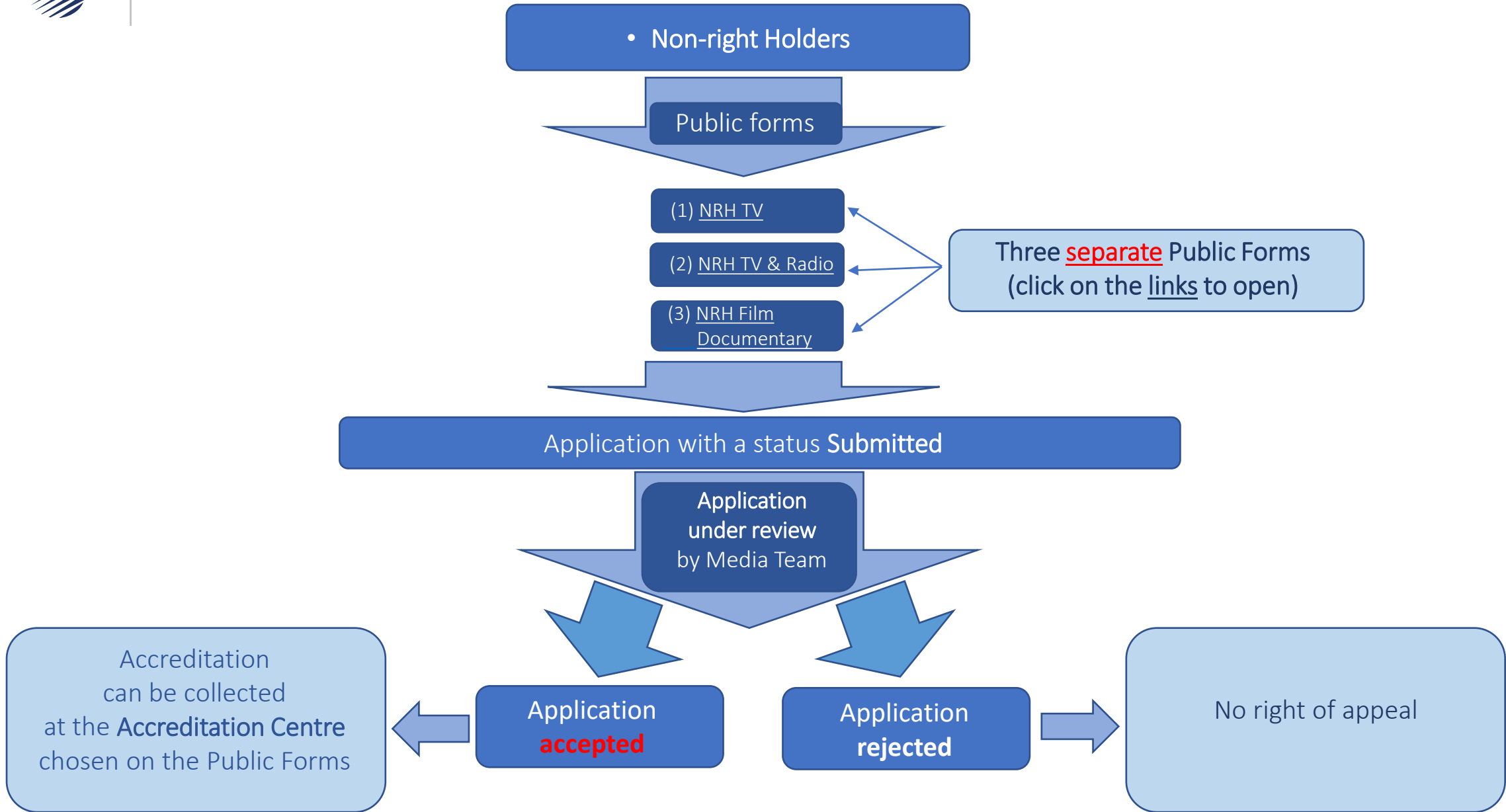
The are three separate Public Forms:

## Media Accreditation Key Dates

DATE	ACTION
by 7 <sup>th</sup> April	→ Start of the Media Accreditation Process
by 15 <sup>th</sup> April	→ Media Accreditation Manual with the link to the Public Forms is to be sent to the media
15 <sup>th</sup> May	→ Deadline for submitting accreditation applications via Public Forms
by 31 <sup>st</sup> May	→ A decision to <b>accept</b> or <b>reject</b> the application for accreditation is to be made
after 5 <sup>th</sup> June (As per Accreditation Centres operational period)	→ Start of Accreditation distribution at the Accreditation Centres – <u>personal collection</u>



## Data scope for Accreditation

- Given name, Family name
- Date of birth
- Gender
- Nationality
- ID/Passport Number (issue date, expiry date, country of issue)
- PESEL\* (Polish citizens only)
- Organization/Title
  - Estimated reach of readers/audience
- Email address
- Phone number
- Disability\* (if applicable)
