TERMS & CONDITIONS

The following Accreditation Terms & Conditions are intended to guarantee the proper and efficient operation of the accreditation process for all persons to whom the European Games Organising Committee (EGOC) has granted accreditation ("Accredited Persons") for the 3rd European Games Kraków-Małopolska 2023 (EG2023) held in Poland from 21.06.2023 to 02.07.2023.

- 1. EGOC reserves the right to reject an application for accreditation for any reason at its sole discretion. In addition, EGOC reserves the right to revoke, modify or restrict the accreditation, to prohibit an Accredited Person from entering areas under the control of EGOC or to eject an Accredited Person from an area for any reason if EGOC considers it appropriate or beneficial to do so. In such a situation, European Games Identity and Accreditation Card (EGIAC) must be returned immediately to the Accreditation Centre upon request by EGOC.
- 2. Accredited Person will be granted access to an area or zone only for the purpose of performing a current and relevant function in that area or zone only if she/he will:
 - a) accept these Terms and Conditions;
 - b) show the accreditation pass (EGIAC), which must be clearly visible at all times when the Accredited Person is performing a current and appropriate function in the area or zone; it must not be worn at any other time; and
 - c) present proof of identity with a recent photograph and signature on request.
- 3. EGIAC remains the property of the EGOC and is non-transferable. It can only be used by Accredited Person and regulates the zones in which Accredited Persons will be authorised to perform their activities. Accredited Persons are prohibited from entering zones that are not covered by their accreditation. You are also not allowed to enter the field of play before, during and after the games, nor the changing rooms, unless you have special permission from the EGOC.
- 4. Accredited Persons shall comply with all guidelines and requirements relating to the safety and security of the Games, including but not limited to all instructions from stewards, security personnel and/or other duly authorised persons.
- 5. Accredited Persons and all other persons at the venue are strictly prohibited from using or possessing promotional or commercial, political, religious or racist items or materials, from giving for sale, selling or possessing with intent to sell goods such as food, drink, souvenirs, clothing, promotional and/or commercial items unless they have written permission from the EGOC. All such articles may be removed or temporarily confiscated by stewards and/or other duly authorised persons.
- 6. Accredited Persons are not permitted to give away or sell accreditation passes (EGIACs and others) or any items relating to them, including but not limited to waistcoats or other accreditation instruments. Passes or other accreditation instruments may not be used for commercial purposes such as but not limited to advertising.
- 7. Accredited Persons are responsible for their EGIAC and shall indemnify and hold EGOC harmless from any damages or liabilities incurred in connection with or as a result of the use of their accreditation passes and/or breach of these Terms and Conditions.
- 8. In the event of loss or theft of EGIAC, the decision regarding whether or not to issue a new EGIAC is made by EGOC. This requires Accredited Person to follow the following procedure:

a) In the event of theft:

- Theft must be reported to the police within 24 hours.
- Confirmation of the theft report must be presented to Accreditation Centre.

b) In the event of loss or destruction:

- Loss or destruction of EGIAC must be reported to Accreditation Centre within 24 hours.
- In the event of loss or destruction of EGIAC, EGOC reserves the right to charge a flatrate compensation of EUR 100 for the issue of a new one.
- 9. During the whole time (both before, during and after the games) it is strictly forbidden:
 - a) recording, using and/or transmitting of sound, images and/or descriptions of the venue (including any results, statistics, information and/or other data relating to the games) for commercial purposes other than for editorial and reporting purposes in permitted publications without EGOC's prior written consent; and/or
 - b) transmission of still and/or moving images of the venue and/or the games for any purpose without the prior written consent of EGOC. Such material may not be formatted so that it can be displayed on mobile devices (e.g. mobile phones, tablets etc.) or websites other than in accordance with paragraph 11 below
- 10. Both the transmission (audio, visual or audio-visual) of the games and/or the venue via the Internet or by means of fixed or wireless technology, as well as the sale or distribution of game commentary in any medium, are expressly prohibited in the absence of specific permission from EGOC.
- 11. Subject to point 9, only images taken by officially accredited photographers may be published in permitted publications on the Internet or via mobile devices if they were taken as still images and not as moving images, quasi-video streaming or slideshows. Regardless of the above, images relating to the games may be published in permitted online publications (via the Internet or otherwise) within at least 20-second intervals between images.
- 12. The trademarks, logos and marks associated with the EGOC and Games must be used in accordance with the guidelines issued by the EGOC; they may not be used for any other purpose without the written consent of EGOC. Accredited Persons may not engage (either themselves or through third parties) in marketing, promotional or any other activities related to the EGOC, the Games or use materials developed by Accredited Persons under accreditation for such purposes without the prior written consent of EGOC.
